

2017 REPLAY QUIZ #14

1. 1/10 @ B-20. The ruling on the field is a touchdown. Replays show that airborne A87 controlled A9's pass:
 - a. landing on both feet at the B-6, then turning, taking a step, and diving for the pylon. Replays also show that:
 - i. the ball firmly in A87's grasp touched the pylon and then came loose.
Confirm the Touchdown. A87 completed the process of the catch by maintaining possession of the ball long enough to perform an act common to the game. He then performed a "second act".
 - ii. the ball slipped from A87's hand just before touching the pylon.
Reverse to a Touchback. B - 1/10 @ B-20. As above, A87 completed the process of the catch, so this is a catch and fumble.
 - b. touching with one foot at the B-3 while falling, then extending for the pylon. Replays also show that:
 - i. the ball firmly in A87's grasp touched the pylon and then came loose.
Reverse to an incomplete pass. A - 2/10 @ B-20. A87 was still in the process of completing the catch, and did not maintain control of the ball as he contacted the ground out of bounds (the pylon).
 - ii. A87 landed with the ball in the end zone, after which the ball came loose and touched the pylon.
Reverse to an incomplete pass. A - 2/10 @ B-20. A87 was still in the process of completing the catch and allowed the ball to hit the ground (the pylon) after he contacted the ground inbounds.
2. 2/15 @ B-45. Quarterback A13 is sacked at the A-45. No foul is called on Team B for the action on A13.
 - a. B96 was offside at the snap. Acceptance of the penalty results in A - 2/10 @ B-40. Replays show that B96:
 - i. lowered his head and used the crown of his helmet to forcibly contact A13 and send him to the ground.
Initiate a 9-1-3 Targeting foul and disqualify B96. There are now two live ball fouls on Team B. Team A will opt for enforcement of the 15-yard penalty from the previous spot. A - 1/10 @ B-30.
 - ii. led with his helmet and forcibly contacted A13 after he was on the ground.
Initiate a 9-1-4 Targeting foul and disqualify B96. There are now two fouls -- one live and one dead -- on Team B, so the 15-yard penalty will be enforced from the succeeding spot. A - 1/10 @ B-25.
 - b. A78 clipped at the 50. Declination of the penalty results in A - 3/25 @ A-45. Replays show that B96:
 - i. lowered his head and used the crown of his helmet to forcibly contact A13 and send him to the ground.
Initiate a 9-1-3 Targeting foul and disqualify B96. There is now a live ball foul on each team. The fouls will offset. A - 2/15 @ B-45.
 - ii. led with his helmet and forcibly contacted A13 after he was on the ground.
Initiate a 9-1-4 Targeting foul and disqualify B96. There are now two fouls -- a live ball on A and a dead ball on B. Team B will now wish to accept the penalty for A78's clip. A - 1/10 @ B-45.
3. 3/5 @ A-30. The ruling on the field is that A24 caught A7's pass near the sideline at the 50 where he was tackled. There was neither a "hat" nor a "flag" associated with A24's movement down the sideline.
 - a. B21 held A24 just off the line. Declination of the penalty results in A - 1/10 @ 50. Replays show that A24:
 - i. went out of bounds on his own, re-established inbounds, and caught the pass.
The pass is complete, but initiate an Illegal Touching foul. There is now a live ball foul on each team. The fouls will offset. A - 3/5 @ A-30 - Ready.
 - ii. went out of bounds on his own, but did not re-establish inbounds before touching the ball.
Reverse to an incomplete pass as the ball is dead when touched by out of bounds A24. Team A will now wish to accept the penalty for B21's hold. A - 1/10 @ A-40 - Snap.
 - b. A24 committed pass interference. Acceptance of the penalty results in A - 3/20 @ A-15. Replays show that A24:
 - i. went out of bounds on his own, re-established inbounds, and caught the pass.
The pass is complete, but initiate an Illegal Touching foul. Team B will now likely wish to accept the penalty for this foul instead as it is loss of down at the previous spot. A - 4/5 @ A-30 - Ready.
 - ii. went out of bounds on his own, but did not re-establish inbounds before touching the ball.
Reverse to an incomplete pass as the ball is dead when touched by out of bounds A24. Team B will now likely wish to decline the penalty for A24's pass interference foul. A - 4/5 @ A-30 - Snap.
