

REPLAY FOR NON-REPLAY TYPES - 2012

Passing Plays [18]

Complete or incomplete:

- [1] Award catch but no advance if replay reverses incomplete to catch. {26}{27}{28}{39}
- [2] Officials rule incomplete. Replay may rule catch and fumble. {29}{31}
 - a. Ball given to recovering team if in immediate continuing action.
- [3] Incomplete pass if airborne receiver loses ball when landing. {30}
- [4] Touchdown if airborne receiver lands on one foot maintaining possession. {33}
- [5] Incomplete if receiver loses ball going to ground in process of catch. {32}{34}
 - a. Receiver may be ruled to have caught ball if several steps taken inbounds.
 - b. Ruling same if contacted by an opponent while going to ground.
- [6] Complete when lands inbounds and maintains control when landing out of bounds. {35}
- [7] Incomplete if heel-toe or toe-heel at sideline unless foot dragged or a delay. {36}{37}
- [8] Complete when one foot inbounds followed by second foot out of bounds. {38}
 - a. Same ruling if receiver hit after foot hits out of bounds.

Pass controlled by airborne receiver at pylon:

- [1] Incomplete pass if airborne receiver touches ball while touching pylon. {40}
- [2] Incomplete pass if contacting pylon at same time foot lands inbounds. {41}
 - a. Illegal touching if pass touched by airborne receiver after touching pylon.

Receiver near sideline and catches pass:

- [1] Official rules did not step out of bounds before catch but did. {42}
 - a. Result is an illegal touching foul.
- [2] Official rules stepped out of bounds before catch but did not. {43}
- [3] Official rules stepped out of bounds before catch but replay shows shoved. {44}
- [4] Official rules out of bounds by contact but replay shows no contact. {45}

Forward/backward pass:

- [1] Officials rule backward pass forward and incomplete but Team B recovers in immediate continuing action. {46}

Passer beyond neutral zone:

- [1] Entire body must be beyond neutral zone. {47}

Illegal forward pass:

- [1] After change of team possession. {48}{51}
- [2] One or two forward passes from behind neutral zone. {49}{50}

Touching a legal forward pass:

- [1] May rule pass touched by Team B if pass interference called. {52}
- [2] May rule pass not touched by Team B if official picks up flag. {53}
- [3] May rule pass touched by Team B before illegal touching called. {54}
- [4] May rule pass touched but not intentional touching by ineligible receiver. {55}

Not reviewable:

- [1] Severity of contact when official rules pass receiver shoved out of bounds. {56}
- [2] Backward pass ruled forward and incomplete if ball out of bounds between goal lines. {56a}
 - a. Replay may get involved if ball goes out of bounds in end zone.
- [3] Ineligible receiver downfield or catches pass, not even under egregious rules. {57}{58}
- [4] Official ruling intentional grounding from behind neutral zone. {59}
- [5] Penalty distance or spot of enforcement. {60}
 - a. Incorrect down may be corrected during series of downs.
